# What is mediation?

Mediation is a process where two people can meet in a safe, neutral place to talk about and negotiate any issues following on from their separation or divorce.

This could be:

- ▶ Arrangements for the children.
- ▶ Issues around property and finance
- ▶ What happens to the house we shared?
- ▶ What about our savings and other assets?
- ▶ What about our debts?
- ▶ What about our pensions?

Mediation is **VOLUNTARY, NEUTRAL** and **IMPARTIAL**.

## The process

Mediation starts with a meeting between the mediator and each adult separately.

This is usually followed by a number of sessions with two adults together that focus on things that are important to you (for example children's arrangements or money/finances).

Meetings usually last an hour each (two hours for financial matters). We can speak to children as part of the mediation process, if you and your child agree to it.

You will need to provide evidence of your income including any benefits you may be in receipt of.
